

Terms of personal data processing for marketing purposes

a) of Act no. 18/2018 Coll. on Personal Data Protection and on Amendments to Certain Acts (hereinafter referred to as the "Act") and Art. 6 par. 1 letter (a) Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data (hereinafter "the Regulation")

1. Purpose of the processing of personal data and legal basis of the processing

The purpose of personal data processing is: marketing (informing about news, discounts and other marketing offers)

Personal data are processed on the basis of: voluntary consent of the data subject according to § 13 par. 1 letter a) of the Act and Art. 6 par. 1 letter a) Regulations Legitimate interests of the operator or a third party

The processing of personal data for the legitimate interests of the controller or a third party shall not take place.

2. Identification of the personal data processed by the data subjects

The data subjects about whom personal data are processed are: newsletter subscribers

Scope of personal data processed: name, surname, email address

3. Identification of beneficiaries, categories of beneficiaries

The controller may provide personal data to authorized entities such as institutions and organizations authorized by a special legal regulation, or to contractual partners (especially intermediaries) who have contractually undertaken to take reasonable guarantees to maintain the protection of the personal data processed, as follows:

With the consent of the data subject or at his / her command, personal data may be provided to another recipient.

4. Transfer of personal data to a third country / international organization

Transfers to third countries or international organizations do not take place.

5. Identification of the source from which the personal data were obtained

Directly from the person concerned (via the operator's website).

6. Retention period of personal data

The Operator processes personal data for the time necessary to fulfill the purpose, but not longer than for 5 years from their acquisition.

7. Profiling

The operator does not process personal data by profiling or in a similar way based on automated individual decision-making.

8. Rights of the data subject

The data subject has the right to request from the controller access to personal data processed about him, the right to correct personal data, the right to delete or restrict the processing of personal data, the right to object to the processing of personal data, the right to ineffective automated individual decisions, including profiling, the right to the transfer of personal data as well as the right to bring proceedings to the supervisory authority. If the controller processes personal data with the consent of the data subject, the data subject has the right to withdraw his or her consent to the processing of personal data at any time.

Withdrawal of consent does not affect the lawfulness of the processing of personal data based on consent prior to its withdrawal. The person concerned may claim his or her rights by sending an email to:

9. Obligation to provide personal data
